

Terms & Conditions: Goodlife & Wyndham Lifestyle Campaign

- 1. **Promoter.** Goodlife Operations Pty Ltd ABN 59 120 953 200 (Goodlife).
- 2. Offer Period. From 8:00am 1 October 2024 to 23:59pm 30 September 2025 AEDT time.
